NEW CUSTOMER FEE- Refundable Deposit	\$100.00	This was created in 2013- Prior residents did not pay this fee. Used for administrative costs and is refundable to them when they sell their home ONLY IF they have on record that they paid this deposit fee when water service initiated.

BASIC	\$60.00/mo.	One allotment receives up to 20,000 gal. /mo.
DUAL BASIC	\$120.00 /mo.	Two allotments on 1 meter receives up to 40,000 gal. /mo. (for 1 dwelling only)

WATER USE 20,001- 30,000	\$.0100 PER GALLON	\$1.00 per 100 gal.
WATER USE 30,001- 40,000	\$.0300 PER GALLON	\$3.00 per 100 gal.
WATER USE 40,001- 50,000	\$.0400 PER GALLON	\$4.00 per 100 gal.
WATER USE over 50,001	\$.0600 PER GALLON	\$6.00 per 100 gal.
STANDBY (no meter no water)	\$30.00/mo.	
STANDBY (with locked meter)	\$45.00/mo.	For use when tampering is an issue / or customer comes and goes.

If a customer comes to us to prove they had a leak and shows receipts and proof of repair we *may* only charge \$1.00 per ONE HUNDRED gallons used over the 20,000 gallon mark. **Subject to board discretion upon review of circumstances.**

Past Due Accounts over 60 days are presented to the ASSSD board for action.

After 90 Days in arrears, there will be a 14 day shut off letter sent. Then there will be a 24 hrs.

shut off notice presented to the homeowner. Within the By-Laws, water can be turned off for

non-payment, and Liens will be imposed on passed due property.

Reconnection fees will be charged at the rate of \$150.00
